# Efficiency of Some Chemical Reagents with Ultrafiltration System in the treatment of Abattoir Wastewater

#### ABSTRACT

The study seeks to evaluate the concentration of some toxicants in abattoir wastewater prior to treatment and after treatment using ultrafiltration system. Samples of water were gathered from the reservoir of wastewater in the Gwagwalada abattoir, Abuja, Nigeria without treatment and labelled S1. Some of the water was subjected to treatment using Chlorine + Alum + Lime (S2), another with Chlorine + Alum + Lime + Activated carbon (S3). Physico-chemical parameters such as: pH, colour, nitrates etc. were analyzed. Trace metals (Zn, Cu, Fe, Pb, Mn, Ni, Co and Cd) levels in the water samples were investigated using Atomic Absorption Spectrophotometer (AAS). Concentration of pesticide residues (µq/L), antibiotics and bacterial growth were also evaluated. The S1, S2 and S3 nitrate concentrations were 271.20, 22.40 and 26.57 mg/L respectively. Level of Zinc, Copper and Lead in the trio samples investigated were within the range 0.14 to 0.24 mg/L, 0.15 to 0.24 mg/L and 0.06 to 0.17 mg/L respectively. Dichlorvos, Lambda-cyhalothrin and Chlorpyrifos were found in the 3 water samples in varying concentration. Only sample S1 shows microbial growth of Salmonella spp., Escherichia coli, Pseudomonas spp., and Shigella spp. at  $52.00 \pm 8.49$ ,  $58.00 \pm$ 31.11, >100 and 10.50  $\pm$ 0.71 CFU/100ml respectively. In S1, 0.05  $\mu$ g/L of oxytetracycline and 0.34  $\mu$ g/ of levofloxacin were found. This study has shown that treating wastewater from the abattoir using ultrafiltration method with some reagents such as Chlorine, Alum, Lime and Activated Carbon can help in removing toxicants and purify it before releasing it into the environment

#### INTRODUCTION

The discharge of effluent (also known as wastewater), rinsing of butchered animals postslaughter, and the disposal of animal remains along with bodily fluids have led to significant environmental issues, impacting not only aquatic ecosystems but also posing risks to human health (Ahmadu et al., 2020). This issue has been ongoing for an extended period but has escalated notably over the past few decades, getting to a vital and concerning level in Nigeria (Arimoro and Ikomi, 2008).

It has been reported that many abattoirs in Nigeria are strategically located near surface water bodies to access affordable water supplies required for animal processing and to serve as a disposal site for the runoff generated during meat processing engagements (Omole and Ogbiye, 2013). The water plied during slaughtering activities has the potential to gather products, contaminants, faecal and even malicious bacteria (Mijinyawa and Lawal, 2008; Ramesh et al., 2009). Untreated abattoir effluent is a combination of fats, proteins, and fibers, leading to a significant presence of organic matter with a possibility of contaminating the rivers and sewage networks (Mulu and Ayenew, 2015).

These wastewater streams are often identified by elevated levels of organic compounds, including parameters like biological oxygen demand (BOD) (the receiving water body, potentially could experience eutrophication) and chemical oxygen demand (COD), along with elevated levels of N, P, malicious microorganisms, suspended solids, and fats, oils, and grease (FOG), arising from sources like blood, carbohydrates, faeces, proteins, and feathers (AL-Mutairi, 2006; Kobya et al., 2005; Oh et al., 2014; Yordanov, 2010). The significant presence of organic matter can be connected to the remaining blood in the effluent (Debik and Coskun, 2009; Dlangamandla et al., 2016).

The advancement of innovative approaches for wastewater treatment includes pressure-driven

membrane processes such as ultrafiltration (which aids in the removal of colloids, suspended particles, and macromolecular substances) and reverse osmosis (which eliminates mineral and low-molecular organic compounds substances) (Yordanov, 2010). Ultrafiltration exhibits outstanding effectiveness in eliminating minute particles, as well as pathogenic microorganisms and environmentally harmful enriched substances (Spasov and Dinkov, 2002). This approach can also decrease the necessity for chlorination and eliminate nitrogen and phosphorus nutrients. Wastewater treated through traditional treatment plants is typically released into the environment, while membrane filtration technology can generate water of sufficient purity for household consumption, crop irrigation, and industrial applications (Ramesh et al., 2009).

Surface assimilation on activated carbon is regarded as one of the most effective techniques employed in the water treatment operation (Keerthana and Thivyatharsan, 2018). Activated carbons possessing a diverse pore size distribution, substantial specific surface area, and unique surface chemistry are extensively employed as versatile adsorbents for capturing substances in both gaseous and liquid phases (Yadav et al., 2015). They are also frequently utilized as adsorbents in the removal of various organic compounds, dyes, heavy metals, industrial pollutants, herbicides, pesticides, and numerous other toxic and hazardous substances (Reza et al., 2020). Activated carbons of this nature can be manufactured from a range of source materials, including coffee wastes (Obaya et al., 2020), coal (Sun, 2016), coconut shell (Gratuito et al., 2008), plantain fruits (Ekpete et al., 2017), maize cob (Egbon et al., 2013), rice husk (Ahiduzzaman and Sadrul Islam, 2016) and sawdust (Yang et al., 2017).

The use of antibiotics in agriculture has exacerbated the proliferation of antibiotic resistance in the human population through the spread of interchangeable environmental

resistance genes (Heuer et al., 2011). Wastewater from abattoirs has the potential to pollute both surface and groundwater. The discharge of abattoir effluent introduces pathogens that can negatively impact land and water quality, posing risks to human, animal, and aquatic ecosystem health while also posing a threat to overall environmental safety (Atuanya et al., 2018). The practices associated with livestock farming and animal processing, including the production of beef, hides, and leather, have had long-term detrimental effects on both land and water resources (Sawalha et al., 2019). Wastewaters or effluents from Abattoir has been reported to frequently contain various pharmaceuticals, including diclofenac, oxytetracycline, tetracycline, and others (Sim et al., 2013; Wei et al., 2011) typically used to treat livestock diseases and endoparasites. Another significant concern is the potential impact of long-term environmental exposure to low concentrations of antibiotics, which can range from nanograms per liter (ng/L) to micrograms per liter (µg/L) (Munoz et al., 2017).

This study is undergone to evaluate the concentration of toxicants (heavy metals, low biological oxygen demand, dissolved oxygen, pesticides, antibiotic microbes that can cause infections) in abattoir wastewater prior to treatment and after treatment using ultrafiltration system.

#### METHODOLOGY

#### Study Area

Gwagwalada town in the Federal Capital Territory (FCT), Abuja, can be characterized as one of the densely populated areas and serves as the headquarters of one of the oldest councils in the Federal Capital Territory, Abuja (Ejaro, 2013). Gwagwalada town is situated approximately 55 kilometers from the Federal Capital City (FCC) within the Federal Capital Territory. Its geographical coordinates place it between latitude 08°55'N and 09°00'N and longitude 07°00'E and 07°05'E. (Balogun, 2001). The Gwagwalada Abattoir is located in the new Kutunku area of Gwagwalada, situated between latitude 8°55' and 8°60' North and longitude 7°05' and 7°11' East. More precisely, the coordinates of the Gwagwalada Abattoir are within the range of latitude 8°55'59''N to 8°55'55''N and longitude 7°03'54''E to 7°03'50''E.

#### Collection of water samples

Samples of water were gathered manually from the top 30 cm of the reservoir of wastewater from the Gwagwalada abattoir, Abuja, Nigeria. The water samples, each totaling 1 liter, were collected in triplicate using amber glass bottles. These samples were collected using a composite sampling technique within a 4-hour interval. Subsequently, all collected samples were stored at a 4°C temperature before additional analysis.

#### Group of water samples

Untreated wastewater was labelled S1, Treated wastewater sample using Chlorine + Alum + Lime was labelled S2 while Treated wastewater using ultrafiltration (Chlorine + Alum + Lime) with activated carbon was labelled S3.

#### Physico-chemical determination

The pH and electrical conductivity of the collected water samples were determined using a pH meter (HI-99130, Italy) and an electrical conductivity meter (JENWAY, multi-3410, UK), respectively. Additionally, Gravimetric method was plied to determine the samples total dissolved solids (TDS) (Sawyer *et al.*, 1994).

The total dissolved solids (TDS) of each sample were calculated plying the following formula: TDS (mg/L) = {(A - B)  $\times$  1000} ÷ sample's volume A represent the evaporating dish weight plus the dried residue

B represents the evaporating dish weight

Dissolved oxygen in mg/L was measured using two different techniques: the optical technique of ProODOmeter and the galvanic technique of ProPlus meter (1.25 mil PE), both manufactured by YSI Inc., Yellow Springs, Ohio, USA.

The turbidity of the water samples was determined using calibrated standard instruments (DeZuane, 1997) alongside the American Public Health Association (APHA) (2017), American Society for Testing and Materials (ASTM), and a turbidity meter (model 2100P Turbidimeter HACH, Colombia, USA) provided by Arachem (M) Sdn. Bhd. Each water sample was kept for few minutes in the sample holder in order to stabilize the reading which were then recorded. Nitrates and nitrites concentration were determined as stated in Olu (2021) and the standard methods of APHA (2017). Also, biological oxygen demand (BOD) was evaluated.

#### Pesticide standards

Plying Yusuf *et al.* (2022) method, pesticide standard of 99% purity was acquired from Sigma-Aldrich (St. Louis, MO, USA). HPLC-grade ethyl acetate from E. Merck (Darmstadt, Germany) was plied in dissolving the stock solutions and the evaluated pesticides from the water samples, include Chlorpyrifos, Glyphosate, Dichlorvos, Cypermethrin, and LAMBDA-cyhalothrin.

#### HPLC-DAD analyses

The analysis was conducted using an Agilent Technologies Series 1200 high-performance liquid chromatography (HPLC) system from Waldbronn, Germany, which was equipped with a diode array detector (DAD). The chromatographic column used was an Agilent Zorbax SB C18 column with dimensions of 250 mm × 4.6 mm × 5  $\mu$ m, and the analysis was performed at a constant temperature of 25°C in the oven. Acetonitrile was the mobile phase plied with ultrapure water for 5 min by the utilization of a 30:70 v/v gradient, for 10 min 100% acetonitrile and for 5 min 15:85 v/v.

#### Antibiotics analysis

Fifty milligram (50 mg) each of Metronidazole, Trimethoprim, Sulphamethoxazole, Ampicillin and Cloxacillin standard were weighed separately into 50 mL volumetric flasks and approximately 25 mL of HPLC grade methanol was added to each flask and the solution shaken for 5 min to ensure complete dissolution of the actives. To prepare the stock solution, 1 mg/mL was achieved by filling up to the mark with HPLCgrade methanol. Subsequently, lower concentration calibration standards, specifically 500, 200, 100, 50, and 10  $\mu$ g/mL, were derived from the stock solution and then transferred into HPLC vials for further examination.

#### **HPLC Analysis of Samples**

Two (2)  $\mu$ L of each sample was carried with the aid of the mobile phases (10 mM KH<sub>2</sub>PO<sub>4</sub>) (pH :3.0) (88%v/v) and Acetonitrile 2 4(HPLC grade) (12%v/v)) over the Stationary Phase (WatersXterra C18 with dimensions of (250 mm x 4.6 mm I.D, 5  $\mu$ m) at a flow rate of 1.0 mL/min. The column temp was 30°C and the detector wavelength was 265 nm. The samples were run for 20 min each.

#### Bacteriological examination

This was done to determine the concentration of bacteria and other microorganisms in the wastewater and treated samples as illustrated by Olu *et al.* (2021) and Ikhide *et al.* (2022) where most probable number (MPN) test was carried out in three (3) steps namely; presumptive, confirmatory and completed test to evaluate the count of bacterial isolates.

#### **RESULTS AND DISCUSSION**

Physico-chemical parameters encompass the conventional parameters employed in water quality assessments (Hamaidi-Chergui and Errahmani, 2019). These parameters comprise dissolved oxygen, pH, temperature, salinity, and nutrients like nitrogen and phosphorus. Additionally, they encompass measurements related to pollutants such as herbicides, insecticides, and metals (Alengebawy, 2021). Table 1 shows the different means of physico-chemical parameters readings obtained from the different water samples analyzed in this study with the available permissible limit stated by World Health Organization and Standard Organization of Nigeria as a guideline.

Water conductivity is a representation of its capacity to conduct an electrical current (Mulu and Ayenew, 2015). In this study from Table 1, the untreated water sample from the abattoir had an electrical conductivity of 773.85  $\mu$ S/cm which was reduced in the treated water samples. The water sample treated with Chlorine (3 mg/L) + Alum (20 mg/L) + Lime (15 mg/L) (S2) and the one treated with Treated with Chlorine (3 mg/L) + Alum (20 mg/L) + Lime (15 mg/L) + Activated Carbon (S3) were 303.4 and 266.9  $\mu$ S/cm respectively.

As stated by Asibor et al. (2020), the pH level is crucial for microorganisms as it plays a significant role in regulating the activity of enzymes, hormones, and proteins that control metabolism, growth, and development. From Table 1, the untreated water sample (S1) from the abattoir pH is 6.59, the S2 water sample had pH 6.53 and each pH was within the range of permissible limit as shown in Table 1 by World Health Organization and Standard organization of Nigeria. The S3 water sample had a pH of 5.79. All the three water samples had pH lower in contrast to pH ranges of 6.9-8.8 of earlier studies on wastewater from likewise abattoirs in Nigeria (Raheem and Morenikeji, 2018). Wastewaters from abattoir are alkaline in nature typically due to the high concentration of organic compounds, primarily made up of proteins (Ogbomida et al., 2016; Padilla-Gasca et al., 2011) but that did not take place with the abattoir water sample used in this study.

Dissolved oxygen (DO) is a critical parameter for the existence of aquatic organisms and is also plied to assess the freshness of a river (Kolawole *et al.*, 2011). In this study from Table 1, the DO was low in the untreated abattoir water sample with a concentration of 0.75 mg/L. The low level of DO can be attributed to the high nutrient composition from the abattoir effluent (Mulu *et al.*, 2013). The DO concentration increased after treatment for both S2 and S3 with a value of 5.01 and 4.51 mg/L respectively.

Biodegradable organic matter present in receiving waters can lead to increased rivalry for oxygen within the environment, resulting in elevated levels of BOD and a subsequent decrease in DO. This situation is harmful to aquatic life and can also impact the quality of sediments and surrounding soil (Asibor et al., 2020). In this study, the BOD of the untreated wastewater has a concentration of 81.81 mg/L. The BOD concentration decreased after treatment for both S2 and S3 with a value of 2.08 and 0.68 mg/L respectively. A drastic reduction in slaughter house wastewater after treated using ultrafiltration method was also reported by Asibor (2020), Eze and Eze (2018) and Yordanov (2010). The BOD values for the treated water were below the maximum acceptable limit as illustrated in Table 1.

Color in water is a measurement of its aesthetic quality or visual appearance (Mulu and Ayenew, 2015). In this study, the wastewater from the abattoir is brownish in color while two treated water samples (S2 and S3) were colorless as indicated in Table 1.

As shown in Table 1, the wastewater (S1) had a high turbidity value of 121.00 NTU, it reduced when subjected to treatment, as indicated with S2 and S3, with the values 12.10 and 30.10 NTU respectively. The elevated levels of turbidity are expected, as they result from the direct dislodge of effluents from the abattoirs (Akpor and Muchie, 2011; Ezeoha and Ugwuishiwu, 2011; Kwadzah and Iorhemen, 2015; Ojo, 2014). The appearance of such a high concentration of turbidity diminishes the aesthetic quality of the receiving water (Asibor *et al.*, 2020).

According to Eze and Eze (2018), total dissolved solids (TDS) serve as an indicator of the presence of various chemical contaminants, including calcium, chloride, magnesium, nitrates, phosphate, potassium, and sodium and an elevated TDS values are indicative of hard water, which can lead to the accumulation of scale in pipes, valves, and filters. This scale buildup can

impair system performance and increase maintenance expenses. It's important to note that high TDS levels can be particularly toxic when accompanied by abnormal pH, high turbidity, or reduced oxygen levels (Eze and Eze, 2018). In this study the wastewater had a TDS (592.85 mg/L) value higher than the acceptable limit as indicated in Table 1. The total dissolved solids were seen to increase in both treated water with concentration value of 1480 mg/L and 1307 mg/L.

Nitrate is one of the chemical parameters commonly utilized as index to assess water quality (Olu, 2021). In this study, the nitrate concentration (271.20 mg/L) from the untreated wastewater from the abattoir was far higher than the acceptable maximum limit as indicated in Table 1.

Nitrate pollution is thought to result from both livestock manure and the application of inorganic fertilizers in agricultural practices (Olu, 2021). Industrial effluents, motor vehicles, and wastewater treatment have been recognized as contributors to nitrate pollution in the environment (Alimohammadi *et al.*, 2018; Asghari *et al.*, 2018; Khosravi *et al.*, 2018). High concentrations of nitrate have been associated with eutrophication (Adeolu *et al.*, 2016). On the other hand, the treated water samples (S2 and S3) had a nitrate concentration value of 22.40 mg/L and 26.57 mg/L respectively and these were below the permissible maximum limit as specified in Table 1.

In this study from Table 1, the nitrite concentration in the untreated wastewater from the abattoir was 139.30 mg/L, and this was very high compared to the permissible limit specified by WHO and SON as indicated in Table 1. However, the nitrite reduced in the two treated wastewater (S2 and S3) as 10.20 mg/L and 11.14 mg/L respectively.

Table 2 shows the different mean concentrations (mg/L) of metals obtained from the different water samples analyzed in this study with the available permissible limit specified by WHO, SON and United States Environmental Protection Agency (USEPA) as a guideline.

Heavy metals are categorized as environmental pollutants due to their toxic influence on the ecosphere (Khalid *et al.*, 2020; Olu *et al.*, 2022). As divulged in Table 2, Cadmium and Cobalt were not detected in any of the water sample analyzed. Hassana and Nuradeen (2021) also reported that Cadmium was not detected in the abattoir wastewater which they investigated.

It is well known that acute zinc toxicity in humans can lead to symptoms such as nausea, dehydration, weakness, abdominal pain, muscle coordination difficulties, and kidney dysfunction (Elemile et al., 2019). Chronic exposure to high levels of zinc can increase the risk of blood cell deformities and may also harm the pancreas (Vaishaly et al., 2015) while elevated copper levels can lead to chronic anemic condition (Igbal et al., 2011). In this study from Table 2, the zinc and copper concentrations of the three samples investigated were within the range 0.14 to 0.24 mg/L and 0.15 to 0.24 mg/L. These results were below the acceptable maximum limit by WHO, SON and USEPA as indicated in Table 2. This observation implies that treatment effected on the wastewater from the abattoir were able to remove some zinc and copper in the wastewater sample.

Lead as a contaminant can accrue in the bones, blood vessels and other vital organs as time progress (Nazir *et al.*, 2015). Lead is not only a carcinogen but also affects the central nervous system of individuals exposed to it. It can result in delayed mental and physical growth in children and may impair their attention span and learning abilities (Omole *et al.*, 2018). In this research work, the level of lead in the three samples of water were higher than the acceptable limit as specified in Table 2, the range was 0.06 mg/L to 0.17 mg/L. Although the treatment of the wastewater did cause reduction in the Lead concentration especially with the presence of activated carbon. Unlike this study, Hassana and Nuradeen (2021) did not detect lead in the abattoir wastewater and the activated carbon treated water sample.

In this study from Table 2, the sodium and calcium concentrations in the treated wastewater were higher than their respective concentrations i.e., 11.24 mg/L and 14.16 mg/L in the raw wastewater from the abattoir, the spike in the concentration of these two elementals can be attributed to the presence of lime and alum among the reagents that were used in the filtration process.

Magnesium is a vital nutritional element for human beings, serving as one of the microelements responsible for various functions such as maintaining cell membrane integrity, facilitating nerve transmission, supporting muscle function, and assisting in DNA replication (Bala *et al.*, 2016). In this study from Table 2, The magnesium levels were higher in wastewater with a concentration of 6.34 mg/L and also the S3 sample concentration was higher than the acceptable limit as illustrated in Table 2. This simply could be said that the activated carbon did not permit effective removal of magnesium from the wastewater.

The potassium was well reduced in the water sample without activated carbon- S2 having a value of 9.87 mg/L compared to the one which pass through activated carbon S3 (11.89 mg/L) that also increased the potassium concentration of the filtered wastewater. The wastewater from the abattoir (S1) has a potassium concentration of 10.07 mg/L

In this study, iron was found in the wastewater from the abattoir (S1) at a concentration of 1.05 mg/L and this was higher than some permissible limit specified by some global agency except

WHO as specified in Table 2 but the treated water (S2 and S3) had no traces of iron in it.

In this study, the manganese in the wastewater from the abattoir was 0.32 mg/L and it was

reduced to 0.13 and 0.21 mg/L in the two treated wastewater S2 and S3 respectively. The water treated with activated carbon could not remove the manganese effectively when compared to where it is absent.

Table 3 shows the different concentrations ( $\mu$ g/L) of pesticide residues obtained from the different water samples analyzed in this study with the available permissible limit specified by World Health Organization as a guideline.

Wastewaters from abattoir frequently contain pesticides plied in the treatment of livestock to eradicate ectoparasites. Additionally, they may contain polycyclic aromatic hydrocarbons (PAHs) originating from human activities, especially the processing of animal skin at the slaughter site (Olaniran et al., 2019). In this study from Table 3, the five pesticides investigated were LAMBDA Chlorpyrifos, cyhalothrin, Dichlorvos, Cypermythrin, Glyphosate. None of the water sample had the presence of Cypermythrin, Glyphosate was obtained as shown in Table 3. Multiple categories of pesticides designed to combat particular pests are manufactured to

enhance crop production and quality (Oladokun 2020). One frequently used et al., organophosphate pesticide, possessing insecticidal characteristics, is Dichlorvos (2,2dichlorovinyl dimethyl phosphate), which is frequently put on crops, stored goods, and for treatment of animal (Moraes et al., 2015; Thredgold et al., 2019). In this research work from Table 3, dichlorvos was found in all the three samples of water at a concentration of 130 µg/L level, this is far above the acceptable limit as specified in Table 3. Also, the treatment applied to the wastewater from the abattoir could not remove organic substance like dichlorvos.

Lambda-cyhalothrin bears resemblance to pyrethroid, specifically cyhalothrin, which consists of four isomers. Lambda-cyhalothrin is derived from two of these isomers. Its mode of action impacts an organism's nervous system by

interfering with the gating mechanism of sodium channels responsible for generating and transmitting impulses of the nerve (Nwadinigwe, 2010). In this study from Table 3, the pesticide Lambda-cyhalothrin was found in the three samples of water, 0.33  $\mu$ g/L in the wastewater from the abattoir, and 0.28 µg/L in two treated water sample respectively. These concentrations were higher than the acceptable limit as illustrated in Table 3.

Chlorpyrifos is an all-around organophosphorus pesticide that contains chlorine and is commonly employed to manage agricultural and household

insects (Sasikala et al., 2012; Tomlin, 2015). Chlorpyrifos, serves as the active ingredient in various insecticides and characterized by its considerable acute mephitic (Noworyta-Głowacka et al., 2012). Chlorpyrifos exhibits potent and indiscriminate pursuit to both human and animal subjects (Lutz and Pałczyński, 2005). In this research work from Table 3, the Chlorpyrifos in the three water samples i.e., the wastewater from the abattoir and the two treated water samples S2 and S3 were 162.85, 162.97 and 163.01 µg/L respectively. These concentrations were higher than the acceptable limit as illustrated in Table 3.

Table 4 shows the different means (CFU/100ml) of bacterial populations in the different water samples analyzed in this study with the available permissible limit specified by World Health Organization as a guideline.

Abattoir wastewater discharged has been found to contain various bacteria, including Escherichia coli, Staphylococcus aureus, Klebsiella species, Salmonella species, Enterobacter species, Shigella species, and Proteus species and when blood and fat are permitted to be channeled through the effluent, the cost of treatment rises significantly. (Joseph et al., 2021; Otolorin et al., 2015).

In this study, the wastewater from the abattoir, show that there was growth of Salmonella spp., E. coli, Pseudomonas spp., and Shigella spp. at 52.00  $\pm$  8.49, 58.00  $\pm$  31.11, >100 and 10.50  $\pm$  0.71 CFU/100ml. On the contrary, there was no microbial growth from the two treated water samples S2 and S3 as indicated in Table 4.

Table 5 shows antibiotic residues ( $\mu$ g/L) in the different water samples analyzed in this study. Oxytetracycline (OTC) is generally plied to treat bacterial attack in humans, are also broadly applied to farm animals for prophylactic and therapeutic purposes, as well as for growth promotion. This is due to their low toxicity status, all-around activity, and cheapness (Kong et al., 2012; Watanabe et al. 2010). Despite at reduced levels, oxytetracycline and its transformation products have been demonstrated to promote the emergence of antibiotic-resistant bacteria (ARB) and antibiotic resistance genes (ARG) evolution, expedition, mobilization, and transmission to pathogens (Bengtsson-Palme and Larsson 2015; Huang et al., 2012; Lundstrom et al., 2016). In this study from Table 5, 0.05 µg/L of oxytetracycline was detected in the raw wastewater (S1) from the abattoir. It was also present in the two treated water sample at a concentration close to that found in the untreated wastewater.

Levofloxacin belongs to the fluoroquinolone drug class as a bactericidal drug, which works by straight inhibiting bacterial DNA production (Bush et al., 2011). It has proficient averse to other prominent respiratory organisms; such as; Chlamydia pneumoniae, Haemophilus influenzae, Legionella spp., Moraxella catarrhalis, and Mycoplasma spp. (Yew et al., 2011). Levofloxacin additionally exhibits greater in-vitro activity against Mycobacterium tuberculosis, making it the desired choice among fluoroquinolones for second-line antitubercular treatment (Anderson and Perry, 2008). In this study from Table 5, levofloxacin was found to be 0.34 µg/L in the wastewater from the abattoir. The treated water S2 and S3 had a reduced concentration of levofloxacin in the tune of 0.30 and 0.15  $\mu$ g/L respectively.

#### CONCLUSION

This study has shown that treating wastewater from the abattoir using an ultrafiltration method with some reagents such as Chlorine, Alum, Lime and Activated Carbon can help in removing toxicants (heavy metals, high biological oxygen demand, low dissolved oxygen, pesticides, antibiotic, microbes that can cause infections,) and also purify it before releasing them into the environment. Considering from the economic perspective, environmental and Ultrafiltration presents itself as a potentially efficient stand-in treatment application in contrast to traditional wastewater treatments. However, purification of wastewater irrespective of its source before releasing it into the environment and water bodies remain a high task to be achieved in developing countries of which Nigeria is not an exception.

#### Recommendations

With the findings made in this study, the authors made the following suggestions

- The water quality of the effluent from the abattoir should always be measured and recorded in order to put some measures in place towards responding promptly to any emergent hazard.
- 2. Livestock breeders should be trained more on the proper usage of pesticides on their animals.

The administration of antibiotics should be done by veterinary doctors or experts that will not allow their abuse and prevent its introduction into the environment via wastewater from abattoir
